- 2. Review break at the 1/2 by #1 "Snappy Dresser" Roger Mayotte, lost a shoe, finished 10th with an equipment break.
- 3. Inquiry, review lapped on break at the wire by #2 "Powerful Mission" Phil Hudon, finished 4 p 5. #2 did receive an interference break as he jumped a head number laying on the track, in accordance with AGCO rules #12:13 (interference may be given to a horse if the break was caused by the equipment of another horse) and rule #22.27 (a breaking horse that is lapped may not be placed for specific reasons) however debris on the track does not fall under that rule.

Inquiry, review break before the start by #10 "Angora Seelster" Chris Matthews, not inside. #10 did cause interference to #9 "Gaelic Lass" Roger Mayotte before the start. Both horses 9 and 10 were refunded, total refund \$20,743.

- 4. #3 "Shagnwiththedragon" Jonathan Drury finished 3rd with a broken check.
- 5. Inquiry, review late stretch #6 "Anikadabra" Rick Zeron and #7 "Majestic Kat" James MacDonald, #6 did not bear into the 7 therefore no placings required, #6 finished 3rd and the 7 finished 4th, both horses received i's (interference).
