Standardbred Directive No. 3 - 2017, changes effective immediately to AGCO rules:

SB 6.02(h). This change will allow an Association to no longer use head numbers.

SB 15.09(a). When a horse is claimed in Ontario, it shall only race at a track or tracks in Ontario for the next 60 days, regardless of whether the track closes for more than 30 days where the horse was claimed.

This Directive was posted in the Mohawk Paddock and Race Office.

Effective this Thursday, horses racing at Mohawk will not be wearing head numbers.

Joe Pereira, violation of AGCO rule #15.09(a), "R U Machin Me" did race outside the province of Ontario within 60 days of being claimed. Monetary penalty \$200., SB50650.
