- Lyle MacArthur met with the Race Officials to discuss an incident in the Test Barn from July 6. Mr. MacArthur was found to be in violation of AGCO Rules 6.02 (b)(e) and 6.17(c)(d) and was given a \$200 monetary penalty. SB 50197.

R1 - All Clear

R2 - Inquiry - reviewed the breaks by #1 Allerage Stargazer (Randy Waples) and #9 Sorceress Seelster (Trevor Henry) before the start - both horses were inside the Fair Start Pole, as confirmed by Trakus.

- Reviewed the break by #6 Shamrock Shaker (Louis Philippe Roy) in the stretch and wire, finished 5th - #6 was lapped by two horses - #5 Jackie Newlands (James MacDonald) and #10 Stormont Chef (Phil Hudon) - at the wire. #6 finished 5th and was placed 7th for a douple lapped on break at the wire.

R3 - Reviewed racing around the final turn and the break by #1 Rough Trade (Billy Davis Jr.). #1 interferes with #2 Rose Run Ranger (Phil Hudon), #4 Jrs Big Buddy (Jonathan Drury) and #7 Six Before Seven (Jack Moiseyev). #2 is forced to leave the track for safety reasons. No placings were required as #1 finished 7th.
