 Ruling SB50663, Driver Randy Waples was issued a 3 day driving suspension, August 22/23/24 2017. Violation of AGCO rule 22.05.01 (a). Mr.
Waples did bear out in the stretch causing interference while driving the horse "Mission Three" in race 4 at Mohawk Raceway on August 10th 2017.
