Trainer Transfer approved for the horse Brookdale Bruiser, from Mike Brealey to Rheal Bourgeois

## Races

Race1 Reviewed pylons in first turn on #1 Youvegotawaywithme (Jamieson), was inside 2 consecutive pylons, and was lapped at the finish. #1 finished 5<sup>th</sup> and was placed 6<sup>th</sup>. Horse was visibly on one line going into turn, no penalty to driver.

Race 2 Inquiry at the start, reviewed the breaks on #'s 1, 2, 3. All horses did get a

fair start, no interference before the start. Also reviewed the breaks on 7 Labero (Byron) and 9 Seven Stars (Henrikson) in the last ½, no violations. #4 Slieve League (Harvey) finished 6<sup>th</sup> and was placed 7<sup>th</sup> for causing interference while off stride to #10 A Doozy (Filion).

Race 3 Johnathan Drury 22.19 "failed to keep both feet in the stirrups". \$100 penalty Sb 49473
