## Backstretch

- Approved trainer transfer on the horses Angels Kid and Excellence from Ian Downey to Andrew Harris.

## Races

Race 1 - All Clear

Race 2 - Inquiry - possible passing lane violation by #2 Princess Jewels (Ryan Holliday) in the stretch, finished 1st.

AGCO Rule 22.05.02.2 reads, 'In the event the home stretch is expanded pursuant of subsection (a), the following shall apply on 1/2 mile tracks: (ii) the lead horse in

the homestretch shall maintain as straight a course as possible while allowing trailing horses full access to the extended inside lane.

The Judges Inquiry reviewed to see if #2 Princess Jewels gave full access to the extended inside lane to #5 Sally De Vie (Anthony MacDonald). Mr. MacDonald stated he planned to use the passing lane, but it was taken away and he went to the outside. Mr. Holliday stated that his horse darted to the inside.

The pan shot shows that Mr. MacDonald goes to use the inside passing lane; however, must check his horse and goes to the outside. The front tower shot shows that #2 Princess Jewels, the lead horse, drops into the passing lane and does not give full access to the trailing horse (#5 Sally De Vie). As a result, the Judges determined that #2 Princess Jewels was in violation of AGCO Rule 22.05.02.2(ii) and would be placed behind #5 Sally De Vie.

#2 Princess Jewels finished first and was placed second for interference by not giving trailing horses full access to the extended inside lane.
