- Race Official Al Stiff is in the Central Adjudication Room and is the author of this report

Backstretch:

- As per policy directive No.1 2009
 The Flamboro Downs card of racing for Thursday February 15th 2018 was cancelled at 2:30pm due to unsafe track conditions. The Judges authorize the cancellation fee of \$300 to be paid from the purse account to the owners of horses that were scheduled to race and not subsequently scratched. Ruling SB49007.
- Senior Race Official Dave Stewart is present in the stand this evening.

Races:

R1 – Inquiry, reviewed racing before the start. #3 JDS Double Dose (Scott Coulter), (finished 8th) did not reach the fair start pole before the start of the race and was a complete pari-mutuel refund (\$3,493). #3 was placed on the Judges list for performance. Trainer Stephen Halkes was notified.

- #9 Townline Striker (Bob McClure), (pulled up after the start and did not finish).

R2 – All Clear

R3 – Recall, #7 Danzing Moon (Travis Henry) suffered broken equipment before the start of the race (head pole)

R4 – The Panel found Driver J Bradley Harris (#5 After Market), (finished 1st) to be in violation of AGCO rule 22.19 (*failure to keep both feet in the stirrups*). Mr. Harris was assessed a \$300 monetary penalty (*second offence within a six month period*). Ruling SB49008.

R5 – Two inquiries.

- Reviewed racing at the ¾ pole between #6 Trisun (Bob McClure), (finished 2nd) and #8 Mercenary (George Ketros), (finished 1st). After speaking to Driver Bob McClure the panel determined that there were no violations of the racing rules.
- Reviewed the break at the start by #2 Trident Seelster (Jody Jamieson), (finished 4th). There were no violations of the breaking rule by #2.

R8 – Reviewed racing in the stretch coming to the wire. #1 Tremendous Play (Scott Coulter), (finished 5th) bears out and interferes with #4 China Dream (Billy Davis Jr.), (finished 6th) and #7 Lyons Sands (J Bradley Harris), (finished 8th). #1 finished 5th and was placed 8th for causing interference to #4 & #7 in the stretch. #4 & #7 were charted with interference in the stretch.

R9 - #5 Red Dog Saloon (Jody Jamieson), (finsihed 4th) finished the race with broken equipment (knee boot).

R10 - All Clear

R11 – Reviewed the break at the $\frac{3}{4}$ pole by #8 Wilma C (Jason Ryan), (finished 5th). There were no violations of the breaking rule by #8.
