Race 1 – Reviewed pylons on #1 Stormont Charlotte (Scott Coulter) in the first turn, finished 3rd - horse hit multiple pylons, no violations.

- #5 JD Luther was checked by Dr. Pat Meyers following the race - reported OK.

Race 2 – All Clear

Race 3 – Inquiry – Reviewed racing at the top of the stretch and first turn pertaining to #6 Majestic Wanda (Nick Steward), finished 4th.

- Break by #6 in the first turn – no violations of the breaking rule.

- At the top of the stretch #6 hooks #3 Facts Or Theory (Scott Coulter) from behind and as those two horses are hooked, #4 Next Kash (Natasha Day) must go inside the pylons for safety reasons. #6 finished 4th and was placed 6th for causing interference. Judges will have Steward in for a film review.
- #3 Facts Or Theory and #4 Next Kash were charted with an 'i' at the top of the stretch.

Race 4 – Reviewed racing at the half between #1 Exodus Seelster (Colin Kelly) and #5 Fern Hill Breeze (Robert Shepherd) - no placings required.

Race 7 – Inquiry/Objection – #9 Evasive Card Shark (Denis St Pierre) on #3 Koultons Rocket (Michael Whelan) in the first turn. Video shows that #8 Strato Boy (Jason Ryan) has room to secure the two-hole ahead of both horses and does not cause any interference. #3 does come down on #9 and causes St Pierre to take a hold of his horse, which forces him inside the pylons and to make a break.

The Driver's Objection was upheld – #3 finished 5th and was placed 8th for causing interference. #9 was charted with an 'ix'. Judges will be following up with Whelan for a film review.
