Senior Race Official Jeff Minler present this evening.

Review with driver Louis Philippe Roy for race 13 from 1 April 2018. Mr. Roy was deemed guilty of AGCO rule 22.05.01 (i) by leaving a hole when it was with the horse's capability to keep the hole closed and was assessed a monetary penalty of \$100.

Review with trainer Jonah Moase regarding TCO2 overage from 25 February 2018 race 8 at Rideau Carleton. Mr. Moase was deemed guilty of AGCO Standardbred rules 22.38 (b), 22.38.01 to 22.38.06 and 26.02.03 (d) by allowing the horse WOGGY ROCKS (8J6231) to race while having a TCO2 level above the permissible limit. Mr. Moase is assessed the following penalties:

- SB 49514 A full suspension for a period of two years from 4 March 2018 to 3 March 2020, inclusive and a monetary penalty of \$10,000 (Mr. Moase was credited with time served).
- SB 49515 A monetary penalty of \$1,000 due to a violation of AGCO Policy Directive 3-2008 (probation) related to SB 38869 & SB 50231.
- SB 49516 Conditions placed on the licence of Mr. Moase for a period of two years from 4 March 2020 to 3 March 2022, inclusive.

It was determined that Mr. Roy did slow up and cause interference to the trailing horses (#s 1, 4 & 9) in contravention of AGCO rule 22.05.01 (g)(i) and was therefore assessed a three day driving suspension to be served 22-24 April 2018, inclusive.
