- #4 Yoooukilis (Travis Henry) did post parade wearing trotting hopples when not programmed to do so. Trainer Patrick Shepherd will be in to see the Judges regarding a violation of AGCO Rule 26.12 (It shall be the responsibility of a trainer to

have the horses under his or her care, and which are programmed to race, properly equipped and in the paddock at least one hour before the scheduled post time or by the time prescribed by the track.)

Race 3 – Reviewed pylons on #3 Hashtag Hughie (Brett MacDonald) around the final turn, finished 3rd – horse was in contact with pylons, no violations.

Race 4 – Inquiry – Reviewed possible interference by #3 Casimir Rumrunner (Paul MacKenzie) on #2 At The Helm (Tyler Moore) in the first turn. The video shows that #3 does bear down going into the turn and causes #2 to make a break. #6 P L Leeroy (Bernard Lavigne) was following #2 and also suffered interference. #3 finished 4th and was placed 6th for causing interference. #2 was charted with an 'ix' and #6 was charted with an 'i'.
