Backstretch

- Doug Hopkins is in the Central Adjudication Room this evening.
- Zoltan Balla was given approval to write his 'F' Trainers License test.
- Taylor Richardson wrote the RUS Rider exam.

- Trainer Michael Kwietniowski was in for a Change of Performance on the horse Monty Mono who competed in Race 3 on April 29. The Judges accepted Mr. Kwietniowski's explanation and will continue to monitor the horse.

- Judges held a Review with Jodie Cullen regarding the eligibility of two horses that raced under her care at Flamboro Downs - Blazing By on April 21 & 28 and Mr Mach Jimmy on April 22. Decision reserved.

- Robert Shepherd was in for a film review of Race 8 on May 3 while driving the horse Astute. Mr. Shepherd was found to be in violation of AGCO Rule 22.05.01(g)(iii) – A driver shall not commit any of the following acts which are considered violations of driving rules: maintain an outside position without making the necessary effort to improve his or her overall position – and assessed a \$100 monetary penalty. SB 50637

Races

Race 1 – Reviewed the break by #2 One Chilly Night (Michael Whelan) coming to the half – interference was given to #5 Cold Creek Lacey (James Gillespie), no placings were required.

Race 2 – All Clear

- #8 Big Debut (Colin Kelly) was checked by AGCO Vet Dr. Chris Robson following the race – nothing to report. The horse must qualify for Performance.

Race 3 – Inquiry – reviewed a possible pylon violation by #9 Mach Magic (Colin Kelly) in the first turn, finished 5th. #9 was ruled inside 2 consecutive pylons in the first turn and did not receive pressure from #3 Dazzling Rockette (Ed Hensley, Fin 3rd). #9 was lapped by #7 Mia Oh My (Robert Shepherd) – finished 5th and placed 6th for a violation of AGCO Rule 18.08.02(a) – *If a horse while on stride, or part of the horse's sulky, goes inside two (2) consecutive pylons, the offending horse shall be placed behind all horses that are lapped on to the offending horse at the wire.*

- #9 was charted with an 'ip' after the start to denote the pylon violation. Judges will review the film with Colin Kelly.
