Backstretch

- Judges held a Review with Dave Menary regarding a Security Report from April 27/18 at Flamboro. Mr. Menary was found to be in violation of AGCO Rule 6.17(c) – *A person, at any time or place, shall not against any official or participant: (c) use insulting, offensive or improper language* – and was assessed a \$300 monetary penalty. SB 50636.

- Colin Kelly reviewed Race 1 on April 28 and Race 3 on May 5 – Judges have accepted Mr. Kelly's explanation and no further action is required.

- Bernard Lavigne reviewed his urging from Race 5 on May 3 while driving the horse P L Leeroy – Mr. Lavigne was found to be in violation of AGCO Rule 22.23.01(b) for excessive action and was assessed a \$200 monetary penalty and 3 day driving suspension, May 13-15. SB 49052.

- Jodie Cullen – AGCO Rules 1.09, 3.02, 5.15(a), and 26.01 – Mrs. Cullen was the programmed trainer of the horses Blazing By and Mr Mach Jimmy that raced at Flamboro, but was not licenced with the AGCO in that capacity. The two horses are

hereby declared ineligible and disqualified from the following races:

- SB 50638 – Blazing By (3HP72) – April 21, Race 11, Finished 4th and April 28, Race 6, Finished 1st

- SB 50639 – Mr Mach Jimmy (3LM75) – April 22, Race 5, Finished 7th

- AGCO Rule 18.08.03 – Purse money must be returned and redistributed.
