From this mornings qualifiers the following individuals were issued a \$200 monetary penalty for a violation of AGCO 6.29.01(b) failure to wear a safety vest while warming up a horse prior to racing:

Greg Peck was issued a \$200 monetary penalty for a violation of AGCO 6.29.01(c) failure to wear a safety vest while jogging, training or exercising a horse at any time. SB 51928.

Jason Ryan was in and received a copy of the certificate of positive analysis from Race 2, Monday 28/18 for the horse Adversity.

### RACES

Race 1 The Commission Vet examined # 6 Shock N Rock after the race. Nothing of concern to report.

Race 2 Clear

Race 3 Reviewed stretch where the winner gets up the inside of # 4 Shezarealdeal. Trevor Henry violation AGCO 22.05.01(e) did allow another horse to pass needlessly on the inside. \$200 monetary penalty. SB 49497.

James MacDonald violation AGCO 22.19 did fail to keep both feet in the stirrups while driving Reis Cross Star. 3<sup>rd</sup> violation within 6 months. \$500 monetary penalty. SB 49495.

Race 4 # 2 Hello Love finished 5<sup>th</sup> and did make a break after the finish of the race.

Race 5 # 3 Summit City Nate finished with broken equipment (lost a shoe).

Race 6 Reviewed stretch where the winner gets up the inside of # 7 Bettors Up. The horse clearly bears out badly while on the lead.

Race 7 # 2 Naughty Lady B pulled up past  $\frac{3}{4}$ 's and did not finish. Horse goes on the list short term sick and must qualify for performance.

Race 8 Jody Jamieson to be in for a film review regarding giving a hole past the  $\frac{1}{4}$ .

Race 9 Ted Nadhazi violation 6.29.01(b) failure to wear a safety vest while warming up a horse prior to racing. \$200 monetary penalty. SB 49496.

Race 10 # 7 Jan was inside 1 pylon around the last turn, no violation. Breathalyzer retest.
