Review with Nick Boyd from 9 June race 4 #6 MIGHTY MACH regarding his
urging at the 1/2 mile pole. The panel accepted the explanation of Mr. Boyd; no

- 2. Inquiry on #1 ROCK N ROLL BABE (James Gillespie) in relation to AGCO rule 18.08.02 (a) (inside two pylons in the last turn); #1 was not lapped and therefore there was no change to the order of finish; no penalty to Mr. Gillespie as the horse was visibly bearing in around the last turn. Clear.

- Reviewed break by #1 SHESTHEREALTHING (Lee Ibey) before the start, no broken equipment and no violations of the breaking rule. Breathalyzer retest. Clear.

Inquiry on #2 SPORTIE GUSSIE (Darcy Clancy) who made a break in the stretch and caused an accident by bearing in while off stride causing interference to #3 DESIRABLE CAM (Matt Harvey) and then beared out hooking wheels with #5 ROCKET GAL (Samara Johnson) causing #2 to fall and Ms. Johnson and Mr. Clancy to be unseated; interference subsequently caused to #4 NOW WHOS THE QUEEN (Justin Turcotte) who was charted with an interference break and to #6 HAZUSEENMYBUCKET (Reg Gassien) who was charted with an interference; neither #2 or #5 finished the race. Both horses were examined by the AGCO official veterinarian Dr. Kyle Goldie who reported both horses suffered only minor abrasions; no injury to either Ms. Johnson or Mr. Clancy. Clear.
