Races

Race 1 – Inquiry – Reviewed #1 Prairie Midnight (Doug McNair) around the final turn, finished 1st. The Panel ruled that the horse went wide on the turn and did not make a break. There was no interference to any trailing horses. No violations by #1.

- Reviewed racing after the start and into the turn. The video shows that #7 Ahi (James MacDonald) gets rough and bears out slightly while #8 Da Delightful (Chris Christoforou) is moving towards the rail, and the horses come together. Both horses were charted with an 'i'. No placings were needed. #3 Century Farroh (Trevor Henry) was charted with an 'i' due to the break by #9 Sunny Beach (Phil Hudon).

Race 2 – Inquiry – Reviewed the break by #4 Mo Bettor (Anthony MacDonald) in the stretch, finished 4th – no violations of the breaking rule by #4.

Race 3 – All Clear

Race 4 – Inquiry – Reviewed racing at the half regarding the break by #10 Stag Party (Doug McNair), finished 1st.

- The Pan Shot shows that #6 Bettors Wish (Paul MacDonell) is advancing first-over and #10 is sitting fourth on the rail as he goes to move out. At this time, #6 has his front legs to the wheel of #10. The Front Tower video shows that as #10 moves out, the horse steps on the outside wheel of #4 Excaliber Seelster (Trevor Henry), which causes him to make a break in stride. The Back Tower video shows that when #10 moves out and makes the break in stride it forces MacDonell out further on the racetrack. Driver MacDonell stated that he had to check his horse and take back. The Judges looked at #4 and determined that he did not cause any interference to #10. As a result, the Panel ruled that #10 did cause interference to #6. #10 finished 1st and was placed 2nd for interference. #6 was charted with an 'i' at the half.
