- Break by #3 at the top of the stretch – the pan and back tower video show that #5 Prologue (Nick Steward) bears down and causes #3 to make a break. #5 finished 5th and was placed 6th for causing interference. #3 was charted with an 'ix' while #2 Music To My Gears (Alfie Carroll), #4 Go Rrrilla (Chris Johnston) and #7 Overload (Robert Shepherd) were charted with an 'i'.

- Break by #6 – the horse broke on his own and no placings were needed.
