Report on day's events:

- Sylvia Toth, Cara Johnston and Crystal Johnston attended the Judge's office regarding an incident in the paddock on 16 September. All concerned have been cautioned that any other instance of improper conduct (AGCO rule 6.17 (d)) will result in exclusion from the paddock for a period of time to be determined by the panel.
- Resulting from the withdrawal of his appeal concerning ruling SB 50378 by driver Mike Healey the penalty of a three day driving suspension is reinstated and will be served 7-9 October, inclusive (SB 50929).

Driver of #2 BESTOFBEST HANOVER, Stephane Pouliot, who finished 7th cautioned regarding AGCO rule 22.05.01 (e) (allow another horse to pass needlessly on the

inside) in the stretch. Clear.

5. Trainer of #5 SEE YOU MEN, Daniel Martin, adjudged guilty of violating AGCO rule 9.11 (horses designated to be tested shall be taken directly to the test barn) and assessed a monetary penalty of \$200 (SB 50935). Clear.

Reviewed performance of #3 REBEL CHILD (Kyle Forgie) who raced in the middle of the track before the ½ mile pole; Mr. Forgie stated that the horse would not steer properly, this horse was found to be asymptomatic by the AGCO veterinarian Dr. L. Attack-Berthiaume after the race, but may have had his tongue over the bit; the trainer, Gavin Christie will make adjustments. Clear.
