- Senior Racing Official Fenton Platts is in the Central Adjudication Room this evening.

- The Judges held a Review with Brett MacDonald regarding his urging in Race 5 on October 11/18 while driving Crazy Alice. Mr. MacDonald was found to be in violation of AGCO Rules 22.23.01(b), 22.23.05(a)(b) – *did use his whip with excessive action* – and assessed a \$500 monetary penalty and 15 day driving suspension, November 3-18/18, Inclusive. This violation was Mr. MacDonald's 3rd offense of the AGCO Urging Rules within one year. SB 49607.
