Report on day's events:

Office:

- On the advice of his physician, driver Simon Delisle is exempt from AGCO rule 6.29.01 (must wear safety vest) (SB 50940).

- Paul Lafromboise excused from one drive.
- Pink Power: Battle to the Wire** with four races featuring the ladies.

 - Driver of #7 PLAYIN FOR KEEPS, Julie Walker, cautioned regarding AGCO rule 22.19 (feet in stirrups). Clear.
 - BUBBLE D MORGAN #6 (Denis Filion), suffered broken equipment (trotting hobble) after the start and broke (charted with an equipment break) and finished 7th placed 8th for a lapped on break at the wire (AGCO rule 22.27); #4 LESTENPERCENT (Rodney Lafromboise) suffered broken equipment (trotting hobble) before the ½ mile pole and broke (charted with an equipment break). Clear.
 - Driver of #4 PRIDE OF PARADISE, Marie Brooking, cautioned regarding her urging in the stretch relative to AGCO rule 22.23.01 (b) (excessive). Clear.
