- Denis St Pierre was excused from his drive in Race 6.

Race 5 – Reviewed the winner #2 Enchanted Mission (Julie Walker) around the final turn. The horse gets rough and does not make a break, no violations.

Race 6 – Reviewed the break by #1 Secret Winner (Scott Coulter) around the final turn. #2 Smoochies Credit (Tom Smith), #3 Block Party Style (Tyler Moore), #4 Eataams Princess (Robert Shepherd), #7 Mach Me Down (Colin Kelly), and #8 Raven Seelster (Paul MacKenzie) all suffered interference. #2 Smoochies Credit did go inside the pylons for safety reasons. No placings needed.
