## Races

Race 1 – Reviewed racing going to the half – #3 Pickem (Ryan Guy) is stopping and causes interference to trailing horses. #5 Dont Write Me Out (Matt Harvey) and #8 Flash In The Pang (Luke Armstrong) were charted with an interference break. #6 Sports Medicine (Reg Gassien) was charted with interference. No placings needed.

- #3 Pickem pulled up at the 3/4s and must qualify for Performance.
- Judges spoke to Luke Armstrong (#8 Flash In The Pang) regarding his urging.

Race 2 – Reviewed #3 Red Hot Torch (Clarke Steacy) at the top of the stretch, finished 3<sup>rd</sup> – horse got rough but did not break.
