- Manager of Racing Operations Mr. Tom Miller in attendance this evening.
- Review with Daniel St. Pierre from 27 June while driving ARRHYTHMOGENIC in the 6<sup>th</sup> race regarding his urging stretch and finish. After reviewing the video of the race and considering the explanation of the participant Mr. St. Pierre was adjudged guilty of violating AGCO rule 22.23.01 (a) (indiscriminate action) and assessed a monetary penalty of \$200 and a three day driving suspension to be served 6-8 July, inclusive (SB 50937).
- Query from a participant regarding why STPATTYSDAY in the 2<sup>nd</sup> race was double entered for Rideau and Trois Rivieres; this horse was a Judges scratch (race office error) in Trois Rivieres today.
