

#### Office:

Review with driver Guy Gagnon concerning race 1 on 18 August 2019 while driving #5 UNDERCOVER BRO concerning interference after the ½ mile pole; the explanation of the participant was partially accepted and no penalty was assigned.

## Races:

- 1. Clear.
- 2. As there were only four starters, 5th place money was retained by the Association (AGCO rule 18.02). clear.
- 3. Inquiry and drivers objection (upheld) concerning possible interference between #3 SPARE SEED (Jonathan Lachance) and #4 ORLYS FURY (Richard Simard); after the start #4 broke stride and did cause interference (charted with an interference break) to #3: #4 finished 5th and was placed 6th (AGCO rule 22.09).

Driver's objection #4 BLACKJACK SOLEIL (Eric Beausoleil) who finished 5th against #1 SPORTS SCENE (Pascal Berube) who finished 4th; Mr. Beusoleil stated that #1 blocked his access to the passing lane; objection disallowed as #1 was not the lead horse at the top of the stretch (AGCO rule 22.05.02.2 (ii)). Clear.

- 8. Start delayed by #8 ZARCONIA SEELSTER (Andrew Moore); Mr. Moore was deemed guilty of violating AGCO rule 22.03 (j)(i) (delaying the start) and assessed a monetary penalty of \$100 (SB 50963).
  - Reviewed the break by #1 BARNYARD DALI (Marie-Claude Auger) after the ¾ mile pole; while off stride #1 did cause interference to #6 DONTTELLTHAWIFE (Robbie Robinson) and #8 ZARCONIA SEELSTER (Andrew Moore), no placing necessary as #1 finished 8<sup>th</sup> (last). Clear.
- Late vet scratch (lame) by the AGCO veterinarian of #4 LOOKIN ATA WINNER, refund: \$144. CAMMANDER RUFF #1 suffered broken equipment (hopple) after the start and finished with broken equipment. Clear.
- 10. Breathalyzer retest. MASTER ELEMENT #3 finished distanced and qualifies for performance (trainer notified); #3 was examined by the AGCO veterinarian who found the horse to be asymptomatic. Driver of #7 MITT JAGGER, Ted McDonald, will attend the Judge's office for a review of his urging. Clear.
