- On Sunday January 26<sup>th</sup>, Officials Stewart, Hopkins and Pote held a Review with Frederick Bourgault regarding Occurrence #19-608 for an incident that took place following Race 3 on December 2/19 at Western Fair. Mr. Bourgault was found guilty of AGCO Rules 6.01(c)(d), 6.20(b) and 6.22, and assessed a \$2,500 monetary penalty and 45 day full suspension, February 17 to April 1/20, Inclusive. SB 49647. Mr. Bourgault also had conditions placed on his licence for one year, April 2/20 to April 1/21. SB 49648.

As the horses advance in the turn, #4 comes back on and the horses hook wheels. The two horses remain hooked throughout the turn and #1 Easy Lover Hanover (Doug McNair) is able to pass both horses along the pylons. The Judges ruled that #6 was initially at fault and finished last; therefore no placings were required. Both #4 and #6 were charted with interference.
