Race 1 - All Clear

Race 2 – Reviewed pylons on #4 Chrissys Girl (Doug McNair) in the stretch, finished 5th. #4 goes inside one pylon at two different points in the stretch, but not consecutively; no advantage gained and no violations of the pylon rule.

- #6 My Mother Pearl (James MacDonald) finished 8th placed 9th for causing interference while on a break to #8 Mystic Delight (Chris Christoforou) and #9 Keep Looking (Jonathan Drury).

Race 3 – All Clear

Race 4 – Inquiry – Reviewed the break by #1 Teeter (Mike Saftic) at the start and possible interference to #10 Keystone Prestige (Sylvain Filion). The Judges ruled that the interference suffered by #10 occurred after the start; all horses received a fair start.

Race 5 – Spoke with Chris Christoforou (#4 Emptythetill) and Bob McClure (#9 Stelios) regarding AGCO Rule 22.19 (keeping feet in stirrups).

Judges looked to see if #4 was forced inside the pylons by #3 Dont Dilly Dally (Louis Philippe Roy); ruled #3 maintains his position on the track and does not contribute. #4 finished 3rd and was placed 8th for racing inside more than three consecutive pylons and gaining an unfair advantage. Judges will follow up with Jamieson on Saturday.
