

Race 3 – Reviewed the break by #2 Smile Sally (J Bradley Harris) – interference to #1 Ally Elizabeth (Doug McNair), #4 Shesonehotwriter (Sylvain Filion), #5 My Baby Girl (Jason Ryan), #7 Southwind Bayou (LP Roy), and #8 Machlikeanegyptian (James MacDonald). No placings needed.

Race 5 – Spoke to Aaron Byron (#7 Size Me Up) regarding AGCO Rule 22.19 (keeping feet in the stirrups).

Race 7 – Judges spoke to Jonathan Drury regarding the performance of #2 Mister Magic. Mr. Drury stated the horse got away third despite the fact he wasn't trotting the best behind the gate. At the quarter his plan was to move first-over (as he did on Jan 30th when he won), but the horse was on a line and so he elected to stay on the rail.
