Race 1 – Reviewed #6 Sportsdrink (Robert Shepherd) at the start, finished 5th – the horse gets rough but does not make a break, no violations.

- #7 Alwaysabeachday (Paul MacDonell) suffered a flat tire in the first turn and finished the race with broken equipment.
- Race 2 Reviewed the break by #5 Threefiftytwo (Bob McClure) in the first turn, finished 5^{th} no violations of the AGCO breaking rule.
- Race 3 Reviewed pylons after the quarter all horses remained on the track.
- Race 4 All Clear
- Race 5 Inquiry X 2 coming to the finish.

- Inquiry #1 Reviewed racing between the winner #5 Cruising In Style (Bob McClure) and second-place finisher #10 Eightoclockstorm (Trevor Henry) before the finish. The front tower video shows #10 bears down slightly more than #5 bears out and the two horses touch wheels. The horses hook wheels and #10 makes a break after the finish. The Judges ruled there was no interference to trailing horses before the finish, therefore there were no violations and no placings were necessary. Both #5 and #10 were charted with interference.
- Inquiry #2 Reviewed racing between #6 Jumpshot (LP Roy) and #7 Trix And Stones (Jody Jamieson) in the stretch. The front tower and apex video shows that #7 changes course and causes #6 to make a break. #7 finished 3rd and was placed 8th for causing interference (AGCO Rule 22.05.01(a)). #6 was charted with an interference break. Jamieson 3 day driving suspension, July 28 30. Ruling to follow.
