- Apprentice Race Official Emma Pote was present for nine Qualifiers this morning.

- Six OSS Grassroots Divisions for 3YO Colts and Geldings Pacers this evening.

- Jody Jamieson – 3 day driving suspension (July 29, 30, 31) – did change course and cause interference while driving the horse Trix And Stones in Race 5 on Tuesday July 21. AGCO Rule 22.05.01(a), Ruling 1043192.

Races

Race 1 – Recall – #5 Messier Seelster (Sylvain Filion) and #6 Sunshine List (James MacDonald) hooked wheels behind the gate. Race All Clear.

Race 2 – All Clear

Race 3 – Inquiry – Reviewed the start for possible broken equipment on #10 Lisvinnie (Phil Hudon). The low pan video confirmed the head check was still on at the start and came undone after the horse made a break. #10 was charted with broken equipment.

- After the top four finishers were displayed on the TV the Judges received a request from driver Sylvain Filion to review the photo finish strip as he felt he finished 3rd. The second review confirmed the correct order was posted and subsequently made official.

Race 4 – Reviewed the break by #6 Noneyabizzness (Denis St Pierre) at the half – #3 Gonnahaveonemore (Sylvain Filion) and #7 Mission Bay (Phil Hudon) were charted with interference. No placings needed.

Race 5 – All Clear

Race 6 – Inquiry – Reviewed racing in the first turn. #2 Watch Ave (Phil Hudon) makes a break and causes interference to #1 Carsons Kennedy (Travis Cullen), #3 Illbewatchingu (Bob McClure), #4 Perseus Seelster (Sylvain Filion), #7 Resounding (James MacDonald), and #8 Lobel Bruiser (Trevor Henry).

- #3 Illbewatchingu, finished 3rd, was forced inside the pylons in the first turn for safety concerns. #3 returned to the racetrack once it was safe to do so and clearance existed. The horse was sitting fifth behind the breaking horse and returned to the track in the same position. The Judges ruled #3 did not gain an unfair advantage by improving his position while in the pylons and was not in violation of the pylon rule.

- #2 finished 7th and was placed 9th for causing interference while on a break.
