Race 2 – Reviewed the start and break by #1 Sky Spirit (Dagfin Henriksen) – #9 BR Serena Slam (Ryan Desroche) was following #2 and did not suffer interference before the start. No violations.

Race 3 – Inquiry – Reviewed the break by #4 Come On Sun (James MacDonald) before the start, finished 4^{th} – no violations of the breaking rule.

Race 6 – Reviewed racing after the half – #1 High Flyin Jamie (Nick Steward) makes a break in the two-hole and causes interference to #3 Lunar Launch (Brett MacDonald). #1 then runs out going to the 3/4s and causes interference to #7 Strong Enough N (Lorne House) and #9 Yannick Seelster (Scott Coulter). No placings needed. #s 3, 7 & 9 all charted with interference.

Race 7 – All Clear

Race 8 – Inquiry – Reviewed racing in the first turn pertaining to #1 Franks Angel (Jason Ryan), finished 1st. #1 makes a quick break while on the lead and lands trotting while remaining on the race course. Once back on stride, #1 hits one pylon and then proceeds to goes off the track and race inside three consecutive pylons. Mr. Ryan stated he felt the need to go off the track for safety reasons; however, the video does not support Mr. Ryan's claim and therefore #1 was in violation of the pylon rule. As per AGCO Rule 18.08.02(b), #1 finished 1st and was placed 8th for a pylon violation.
