- \#1 Vino Louie (J Bradley Harris) finished distanced and must qualify for Performance, Tr. Clare Bradshaw notified. Dr. Meyers checked the horse following the race and reported OK.

Race 2 - Inquiry X 2 at the top of the stretch.

- Inquiry \#1 - Reviewed possible pylon violation by \#2 Flash Cube (Guy Gagnon), finished $2^{\text {nd }}$. The front tower video shows \#2 races inside the yellow pylon that leads into the open stretch passing lane. AGCO Rule 22.05.02.2(iii) reads, 'horses using the open stretch must first have complete clearance of the pylons.' The Panel ruled
\#2 gained an unfair advantage on \#6 Socrates Blue Chip (Bob McClure) by entering the open stretch passing lane without complete clearance. As a result, \#2 finished $2^{\text {nd }}$ and was placed $4^{\text {th }}$ for a pylon violation.
- Inquiry \#2 - Reviewed the break by \#5 Candy Trader (Sylvain Filion), finished 3 ${ }^{\text {rd }}$ PL $2^{\text {nd }}-$ no violations of the AGCO breaking rule.
