- Early Judges scratch (race office error) of GENERAL LEE from the second race.
- Early Judges scratch (injured) of BADSTORMANYPORT from the fourth race by the AGCO veterinarian.
- Virtual review held with driver Tyler Jones concerning AGCO rule 22.05.01(h) (strike another sulky) while driving BADSTORMANYPORT in the seventh race at Rideau on 22 October. Following the race the AGCO veterinarian examined this horse and determined to be injured. The explanation of Mr. Jones was partially accepted and no penalty was assigned.
