- Ruling entered for Marie-Claude Auger concerning violation of AGCO rules 22.23.01(a) (indiscriminate), 22.23.02(a) (horse not visibly responding) and 22.23.03(b) (more than acceptable wrist action) while driving MCJAGERSONTHEMOVE in the ninth race on 25 October; assessed a driving suspension of three days (27-29 October, inclusive) and a monetary penalty of \$200 (Number 1095402).
