- Early Judges scratch (ineligible) of GENESEE from the first race as this horse was purchased by the previous owner within 30 days of being claimed and returned to the same stable in violation of AGCO rule 15.18 (ineligible to start in any race in the name or interest of the original owner, or be returned to the same stable or trainer, for 30 days). GENESEE is ineligible to be entered until 25 November (Number 1102512).
- Owner/trainer Matthew McDonald was adjudged guilty of violating AGCO rules 15.18 and 11.04 (declaring an ineligible horse) regarding GENESEE (see above) and assessed a \$200 penalty (Number: 1102587).
