- Receipt of Certificate of Positive Analysis quantifying cobalt (Class 3) at 145 ng/mL (above the allowable limit of 100 ng/mL) in the official urine sample (Tag # 45 20310008) obtained from the race winner PL GYRO (0HM01) of race 6 on 5 November at Rideau; Andre Champagne trainer.
 - PL GYRO (0HM01) is ineligible to be entered for a period of 30 days (22 November to 21 December, inclusive per AGCO rules 9.07.01(iv) (determine eligibility of horse upon notification of positive result) and 20.01.01(i) (horse place on Judges list) (Number: 1110957).
 - Mr. Champagne was informed by telephone; disclosure will be forthcoming.
- Early Judges scratch (transportation) of CANADIAN EDITION and JK ELLEM ENOH from the sixth race, and KWIK TALKIN from the seventh race.
- Early Judges scratch (weather) of MISTER GODRO from tenth race.
- Gary McDonald adjudged guilty of violating AGCO rule 6.20(b) (misconduct prejudicial to the best interests of racing) concerning the claim of THUNDERING JIM on 18 October from the eighth race at Rideau and was assessed a monetary penalty of \$200 (Number: 1111039).
