Race 5 # 6 Lady Caterina was scratched Judges Ineligible due to an issue with the owner Blueshoe Investments. All horses owned by Blueshoe Investments are ineligible to race in Ontario until the issue is resolved.

Race 6 Reviewed pylons after the start going into the 1st turn. No violations.

Race 7 # 7 River Dali (N. Steward) finished 5^{th} and was charted with an interference break after the $\frac{1}{2}$ when # 8 Coin Flip (S. Wray) did hook wheels with # 7. No placings needed.

Race 8 Inquiry. # 1 Mo Bettor (B. Macdonald) finished 2nd and was placed 3rd for going inside 2 consecutive pylons after the start into the 1st turn and was lapped on. No penalty to driver Brett Macdonald as horse is visibly bearing in.
