### Office:

- Notice of Positive Analysis from 7 March at Rideau Carleton:
  - Horse: BET TILL DAWN (2LR04); this horse is entered on the Judges List (AGCO rule 20.01.01(j)) and is ineligible to be entered to race for a period of fifteen (15) days (20 March to 3 April, inclusive) (Number 1177138).
  - Trainer: Kathy McBride
  - Result: altrenogest (class 4) (race 8, finished third) (Tag #: 4521066013)
  - Ms. McBride has been informed of the positive analysis and her obligations regarding movement of horses to other trainers, and will receive disclosure imminently.
- Early Judges scratch (ineligible) of BET TILL DAWN from the fourth race.
- Early Judges scratches (injured) of SPORT A LUCKY STAR from the first race and EAU NATURELLE from the second race.

### Races:

- Inquiry videos are not available as neither the OnTrack video operator nor the Judge's can access the AGCO Race Replay portal.

1. Reviewed the break by #8 TJ THUNDER (Stephane Brosseau) after the ½ mile pole; while off stride #8 did cause interference to #9 PHILLY FREEDOM (Jason Gilchrist); no placing necessary as #8 finished ninth (last). Clear.
2. Clear.
3. Recall as #4 PERFECT DALIANCE reared, unseated the driver (Tyler Jones) and ran loose, refund: \$3452; #4 qualifies for starting and performance (trainer notified). Clear.
4. Inquiry on #7 THATS SOME PLAN (Pascal Berube) concerning possible interference to #2 SENIOR K (Mike Healey) at the ½ mile pole; no violations. Clear.
5. Late Veterinary scratch (sick) of #8 OUTLAWDANCEWTHHEDEVL, refund: \$49; #8 is entered on the short term vet list (seven days). Clear.
6. Reviewed the break by #3 MICHELE Z TAM (Robbie Robinson) before the ¼ mile pole; while off stride #3 did cause interference to #5 ER RHONDA (Tyler Moore) and #6 LADY LAKESHORE (Denis Audet); no placing necessary as #3 finished ninth (last). Clear.
7. Clear.
8. Clear.
9. Reviewed racing in the last turn regarding #6 JEFFS JOURNEY (Richard Simard), who finished fourth, leaving the course; #6 was inside one pylon, no advantage gained and no violations. Clear.
10. Inquiry on the performance of #1 CROSSFIT (Marie-Claude Auger) who broke after the ¾ mile pole, stretch and finish and suffered broken equipment (trotting hopple) after the break in the stretch; #1 finished fourth and was placed sixth for failure to continuously lose ground while off stride (AGCO rule 22.27) and finished with broken equipment. Clear.
11. Late driver change on #3 MARACASSO from Stephane Brosseau to Tyler Jones as Mr. Jones was the driver of record on the overnight entry sheet and Standardbred Canada; Racing Manager Peter Andrusek will investigate how the official program had the wrong driver listed.  
  
Delay due to broken equipment (shoe) on #5 WINDSUN CHEYENNE. Recall due to broken equipment (stepped out of hopple) on #4 SHADOW MARGEAUX. Clear.
12. Official warning entered on the licence of the driver of #6 BARRYS SHELBY, Ryan Guy, regarding his urging in the stretch. Clear.
13. Clear.
14. Late Judges scratch (injured) of #4 YC BROADWAY, refund: \$71. Clear.
15. Reviewed the break by #4 SOMEWHERE BETTOR (Pascal Berube) before the start, #4 did not have any broken equipment and was well inside the fair start pole when the starter released the field. Clear.
