Office: A Review was held with Doug McNair regarding Race 3 at Mohawk on October 29/22. Mr. McNair was found to be in violation of AGCO Rule 22.19 (did fail to keep both feet in the stirrups while driving Grace Hill) and assessed a 5-day driving suspension (Dec 14-18). This is Mr. McNair's 4th violation of AGCO Rule 22.19 within six months and is therefore referred to the Director of the Regulatory Compliance Branch for determination of further sanction.
