Report on day's events:

Office:

- Katelynn Rourke in training this evening.
- Early Judges scratches (ineligible) of PRETTY BOY DUKE from the fourth race, NO TIME AT ALL from the sixth race, FLASH TO THE FINISH from the seventh race and SUNNY BO and YS MATHIS from the ninth race.
- Early Judges scratch (other) of NIGHT CLUB HANOVER from the second race and MAJOR HILL from the sixth race.
- Early Judges scratches (injured) of WESTERN PHIL from the fourth race and STONEBRIDGE HERMES from the tenth race.
- Program correction announced for SPICY RED HEAD in the first race; this horse is removed from the EIPH program and did not receive Lasix before competing.
- Matthew McDonald did not attend the Judges office to receive disclosure; the Panel will follow up with Mr. McDonald next week.
- Virtual review held with driver Samuel Fillion regarding NIGHT CLUB HANOVER in the seventh race on 16 October concerning AGCO rule 22.05.01(g)(i) (slow when in front); no regulatory action is required, although he was reminded of a drivers' obligation when cutting the mile.

- Virtual review held with driver Ryan Guy regarding STAR DOG in the tenth race on 30 October concerning AGCO rule 18.08.02(a) (leaving the course) in the last turn; official warning entered on the licence of Mr. Guy concerning this rule.

1. Late Judges scratch (injured) of TWIN B HARRY by the AGCO veterinarian, Dr. L. Attack-Berthiaume; refund: \$49. Clear.
- Delay for the second race to allow a field of eight dinosaurs, one hippopotamus and a unicorn to contest a ½ furlong open (finished in a triple dead heat) in support of the Ottawa Food Bank.
