

There were three weather related scratches today.

Trainer Jay Polifroni was in violation of Rule 20.03.0(i), did cause a stable error scratch with the horse Malvolio from Race 3. \$100 monetary penalty. Ruling #1997613.

From Race 3 on December 19<sup>th</sup>, 2022, driver Michael Whelan was found in violation of AGCO Rule 22.19, did fail to keep both feet in the stirrups while driving Fixed Idea. \$100 monetary penalty (first offence). Ruling #1997629.
