Ruling 203641 issued for the horse Quan Blue Chip. The claim from Race 6, January 23, 2023, is ruled invalid due the positive TCO2 test and the horse is to be returned to Gino Toscani.

Tyler Jones was in for a film review regarding his drive on # 6 Quick Fix in yesterdays 1<sup>st</sup> race. Mr. Jones had never previously driven the horse and was a late driver change. He was informed by the trainer that the horse spooks easy and to be careful with the whip. It is better to yell if needed and the horse responds better to that. He indicated that he couldn't move the horse to the outside in the stretch because he didn't have clearance, otherwise, he felt he could have won the race. When he moved to the inside the horse was on the left line, trying to run out, and he was just trying to keep the horse from making a break. No further action required at this time.
