#### OFFICE

- Matthew Gregory training this evening to be a Race Official.
- Due to freezing rain and wind, there is no Apex Video this evening. The Front Tower was operational starting in Race 2 and the Back Tower in Race 3.
- A strong head-wind down the backstretch, the weather and track conditions are causing slower second and third quarters this evening. Judges spoke to a couple drivers throughout the night about the second quarters.

### **RACES**

Race 1 – Judges spoke to Driver Bob McClure regarding his driving strategy with 4-5, #6 Angelwithattitude. McClure stated the horse was running in on the first turn and is not the best gaited horse to drive. He elected not to move at the quarter as he did not feel the horse would be able to sustain a first-over trip into the strong wind and clear to the front. He anticipated that #7 Laa Dee Gaa (LP Roy) to his outside would advance so that he could possibly follow cover instead; however, the horses behind him started moving and he was unable to move off the rail. As a result, the horse was shuffled to last around the turn and closed to finish 5<sup>th</sup>.

The race fractions were corrected to :28, :59, 1:29, 1:57.1.

Race 2 – Inquiry – Reviewed the break by #6 MVN (Sylvain Filion) after the start, finished 4<sup>th</sup> – no violations of the AGCO breaking rule.

Race 8 – Reviewed racing in the first turn – #3 R Hot Toddy (Bob McClure) races inside one pylon, no violations of the AGCO pylon rule.

Race 9 – Inquiry/Accident at the finish – #8 Sunshineinmypocket (Sylvain Filion) is trying to split horses coming to the wire and gets her front foot stuck in the bike of #7 Sunshine Sally (LP Roy). #8 subsequently makes a break and falls to the track. #6 P L Ooooooooooyah (Jody Jamieson) is unable to avoid #8 and falls over that horse. Both horses were observed by Association Vet Dr. Ballinger and #8 suffered a lip laceration. Jamieson was OK to continue driving. Filion booked off Race 11. No change was needed to the order of finish. No inquiry video posted.
