- Test strips were utilized in races two and four.

R1 – The Judges reviewed racing into the last turn. #1 Miss M A K (John Gouveia), (finished 9<sup>th</sup>) hooks the wheel of #8 Million Angels (Jason Ryan), (finished 8<sup>th</sup>). No placings are required. Driver John Gouveia was assessed a three-day driving suspension for causing interference. The penalty shall be served from April 2 through April 4<sup>th</sup>, 2023, inclusive. Ruling #2110567

R2 – #2 Kiss My Mass (Scott Coulter), (finished 9<sup>th</sup>) finished the race with broken equipment (lost a shoe).

R3 – Inquiry, reviewed racing around the last turn. #4 A La Mode Seelster (Travis Henry), (finished 2<sup>nd</sup> and was placed 5<sup>th</sup>) comes out and interferes with #8 No Time (Jay Harris), (finished 5<sup>th</sup> and was placed 4<sup>th</sup>). #4 finished 2<sup>nd</sup> and was placed fifth for causing interference to #8 going into the last turn. The Judges will hold a film

review with Driver Travis Henry on Thursday.

R4 – #4 Country Charm (Carl Dawson), (finished 8<sup>th</sup>) makes a break just after the half and causes interference to trailing horses. No placings are required.

R5 – All clear.

R6 – Driver Cory Kreiser (#2 Ellagator, finished 2<sup>nd</sup>) was given a warning about using more than acceptable wrist action. The warning was entered into the iAGCO portal.

R7 – Inquiry, reviewed racing going into the last turn. #7 JMR Mach Mel (Samuel Fillion), (finished 4<sup>th</sup> and was placed 5<sup>th</sup>) goes into a tight spot and then comes out to the #8 Howmacfiesty (Jay Harris), (finished 5<sup>th</sup> and was placed 4<sup>th</sup>). #7 finished 4<sup>th</sup> and was placed 5<sup>th</sup> for causing interference to #8 around the last turn. Mr. Fillion will be in for a film review with the Judges tomorrow.
