- Test strips were utilized in race one.
- From last week (*April 1, 2023*) in race three. The Judges reviewed the interference violation with Driver Travis Henry. Mr. Henry stated that his horse was shying away from the whip of the horse in front of him and went out to the horse beside him. The Judges accepted Mr. Henrys explanation. There was no penalty to Mr. Henry.
- From last week (*April 1, 2023*) in the second qualifier Horse Person Nicholas Steward was found to be in violation of AGCO rules 1.09 and 3.02. Mr. Steward did participate in activity for which he was not appropriately licensed and is subject to a \$100 monetary penalty. Ruling #2119393.
- Flamboro Downs is suffering from technical issues with their tote system, the races were delayed for an hour. After the delay, the races were conducted with no wagering available and were for purse money only due to the tote communication issue.
