 Virtual review held with the driver Drew Smyth concerning his urging of MIDNIGHT SURF in race 10 on 12 April in the last turn; an official warning is entered on the licence of Mr. Smyth concerning AGCO rule 22.23.01(b) (more than acceptable wrist action).

Races:

- 1. The #4 JJ PATRICK (Pascal Berube) suffered broken equipment (knee boot) after the 3/4 mile pole and was victorious with broken equipment. Clear.
- 2. The #8 FULL SPEED STEVE (Stephane Brosseau) had not reached the fair start pole when the starter released the field and did not receive a fair start (AGCO rule 22.03(I)); refund: \$1763; #8 pulled up after the start, did not finish and must qualify for performance (trainer notified).
