

Report on day's events:

(Accidents, claims, fines and/or suspensions, objections and/or disqualifications, refunds and any other pertinent incidents)

Office:

- Discussed accident protocols with Manager of Racing Peter Andrusek concerning allowing access to the track after warning lights are activated and clearing the track to deal with loose horses.
- Review held with driver Jimmy Gagnon concerning AGCO rule 22.09 (contact another sulky) while driving DAY DELIGHT in the ninth race on 2 April; after reviewing the video and discussing the actions of both drivers the explanation of Mr. Gagnon leading to contact with the wheel was partially accepted and no penalty is assigned, although he was cautioned and reminded of a drivers' obligation to prevent contacting another sulky.

- 1. The #6 NOBLE ED (Pascal Berube) suffered broken equipment (shoe) after the start and finished with broken equipment. Discussed race pace with the driver of #1 BETTERONTHEISLAND, Guy Gagnon, concerning the second guarter (27¹ 57³); Mr. Gagnon was reminded of his obligation regarding AGCO rule 22.05.01(k) (set a pace comparable to class). Clear.
- 2. Inquiry on the performance of #1 ROCK N ZEUS (Robbie Robinson) who broke before the start and finished fourth; no violation of the breaking rules. Clear
