#### OFFICE

- Matt Gregory training this evening.
- Phil Hudon 3-day driving suspension (May 30, 31, June 1) did cause interference while driving the horse Ron in Race 10 on May 21/23. AGCO Rule 22.05.01(a)(g.i), Ruling #2191224.
- Judges spoke to Gerard Demers about the change of performance with the horse Big Bad Mosa from Race 7 last night. Mr. Demers claimed the horse last week and made a few tweaks with the horse's bit and bridle that he felt would help, as he thought the horse may have shut off her air in the previous start when racing in the two-hole. The horse showed speed racing in the USA last year and felt the horse would be better on the front. He told Driver Jason Ryan to let her roll on the lead. The horse went gate-to-wire in 1:54.2 as the heavy favourite.
- Colin Kelly 3-day driving suspension did cause interference while driving the horse Tanzania in Race 1 on May 27/23. Ruling to be issued.
- In Race 1, #2 Warrawee Yay was entered to race without hopples. The horse was programmed incorrectly with hopples. The change was announced to the public.

## **RACES**

Race 1 – Reviewed multiple breaking horses in the race – no placings were needed.

Race 2 – Reviewed racing at the 5/8ths when #2 So Strange (Travis Cullen) moves out of the two-hole – horse does have room and clearance, and no interference to #6 Simon Said (Colin Kelly).

Race 3 – Billing Driver Series – reviewed racing at the quarter – #2 Fast As Phelps (Matthew Zuccarello) was charted with interference from #7 Mister Big Top (Marc Andre Pilon) crossing over in front of him. No placings needed.

Race 4 – #6 Kenogami Courage (Jason Ryan) was charted with an interference break due to the break by #4 Belvedere Bronx (Dagfin Henriksen) after the start. No placings needed.
