Office:

- Program error correction in the second race for SOMEHOPESOMEWHERE; this horse is not entered on the EIPH program and did not receive Lasix prior to racing.
- Early Judges scratch (injured) of PERPETUAL ROCK from the tenth race.
- Trainer Yves Tessier attended the Judge's Office to receive disclosure regarding the positive result for LITTLE MANNY (3RP53) from race 3 on 30 April 2023 at Rideau Carleton.
- AGCO veterinarian Dr. Linda Berthiaume Atack attended the Judges office to discuss EIPH protocols and vet technician proficiency.

Races:

- The video technician is unable to upload any inquiry video segments this evening due to computer issues.
- 1. Inquiry on #2 JITTERBUG FLIP (Pascal Berube) concerning the inner rail rule around the last turn; #2 did contact two consecutive pylons but did not go inside either; no violation of the inner rail rule. Clear.
- Reviewed the break by #1 CHASING GOOSEBUMPS (Stephane Pouliot) before the ³/₄ mile pole; while cutting the mile #1 did go off stride and cause interference to the field (all other horses charted with interference); #1 finished sixth placed seventh (AGCO rule 22.09). Clear.
