Office:

- Review held with Drew Smyth concerning his urging of INCREDIBLE HALL in the first race on 4 May; Mr. Smyth was adjudged guilty of violating AGCO rules 22.23.03(b) (more than acceptable wrist action) and 22.23.01(b) (excessive) and assessed a monetary penalty of \$300 and five (5) days driving suspension (23-27 May, inclusive) as this was the participant's second violation of the urging rules within a period of one year (Number 2162835).
- Decision rendered regarding the conduct of Drew Smyth towards the Race Officials following the tenth race on 23 April; Mr. Smyth was adjudged guilty of violating AGCO rule 6.02(b) (use of offensive or profane language) and was assessed a monetary penalty of \$200; violation of this rule breaches the condition of ruling number 1792277 from 10 July 2022 against Mr. Smyth wherein seven (7) days full suspension were stayed to be reinstated for any conduct violations for AGCO rules 6.02 or 6.17 within a period of one year; Mr. Smyth is therefore fully suspended for a period of seven days (28 May to 3 June, inclusive) (Number 2162831).
- Reviewed race 1 from 19 April concerning racing between Mr. Smyth (ROAD READY WES) and WELLWORTHTHEWAIT (Guy Gagnon) and race 1 from 30 April concerning Mr. Smyth's urging of ASHLEES SUPREME.
- Meeting with Jeff Taylor regarding his trainer's licence.
