Report on day's events:

Back Office:

- Trainer Craig Barss was found to be in violation AGCO rule 17.17 *(scratching a horse without the Judges permission).* Mr. Barss did scratch his horse Airline Pilot from race ten this evening and did not have the Judges permission. Mr. Barss is subject to a \$100.00 monetary penalty. Ruling #2319374.
- From last week (08/19/23) in race one while driving the horse Mae Lose Control, Driver Chris Rogers was found to be in violation of AGCO rule 22.23.03 (b) (urging violation, more than wrist action). Mr. Rogers is subject to a \$200.00 monetary penalty and three-day driving suspension that shall be served on August 30, 31 & September 1, 2023. Ruling #2319418
- Test strips were utilized in race five.

R2 – The Judges spoke to Driver Ryan Guy (#2 Matts Tuition), (finished second) about the fractions in this race, 1/4: 26, 1/2: 56. Mr. Guy understands what is expected going forward. There was no confusion going to the half.

R3 – The Judges spoke to Driver Samuel Fillion (#3 One Last Bet), (finished first) about the fractions in this race, 1/4: 26.3, 1/2: 56.4. Mr. Fillion understands what is expected going forward. There was no confusion going to the half.

R4 – Judges inquiry, reviewed racing in the stretch concerning #7 D A Jiminy Cricket (Mike Saftic), (finished third). #7 gets rough as they are coming to the wire but does not make a break.

R5 – Driver James Bailey (#8 Thankyaverymuch), (finished seventh) was found to be in violation of AGCO rule 22.03 (j)(vii) *(starting violation).* Mr. Bailey is subject to a \$100.00 monetary penalty. Ruling #2319470.

R6 – All clear.

R7 – All clear.

R8 – The Judges spoke to Driver Brad Rae (#3 Starlit Elmo), (finished second) about the fractions in this race, 1/4: 28.4, 1/2: 100.4. Mr. Rae understands what is expected going forward. There was no confusion going to the half.

R9 – Judges inquiry, reviewed the break by #1 Texaco Man (Loic Gueriel), (finished fifth). The horse run on his own and did not lose a show as reported.

R10 – All clear.
