- 1. Inquiry on #4 DELCO DYNAMO (Stephane Pouliot), who finished fourth, concerning possibly leaving the course in the last turn; #4 did go inside one pylon and did not gain any advantage; no violations.

Reviewed the performance of #1 OTHER PEOPLES BEER (Guy Gagnon) concerning a possible break at the top of the stretch; #1 was rough but did not break. Clear.

2. Discussed race pace (27 57⁴ 126 155¹) with the driver of the race winner #5 WRANGLE CASH, Guy Gagnon; considering the class, how the race unfolded (#5 did not reach the front until after the ¼ mile) and that the trailing horses were not impeded the panel does not consider this to be a violation of AGCO rule 22.05.01(k) (pace comparable to class) and no regulatory action is required.

Driver of #4 PRINCE GIOVANNI, Stephane Pouliot, will attend a review regarding his urging in the stretch. Clear.

- 3. Start delayed as the driver of #3 REALRUBIES AT PLAY, Jason Gilchrist, dropped a drivers' kit item when turning in towards the starting gate. Clear.
- 4. Driver of #4 IMA DUDE, Melanie Plourde, will attend a review regarding her urging in the stretch. Clear.

- 9. Late veterinary scratch (lame) of MISSION BY AGCO veterinarian Dr. M. Rocheleau; refund \$5441; this horse is entered on the short term (seven days) Veterinarians list.
 - The #3 JON SNOW (Pascal Berube) suffered broken equipment (hopple) before the ¾ mile pole causing this horse to break stretch and finish (charted with an equipment break); #3 was lapped on by #6 WHISTLER (Robbie Robinson) at the finish; #3 finished fifth place sixth per AGCO rule 22.27.
- 10. Reviewed racing before the ¾ mile pole concerning possible interference between #4 LANGLEY SEELSTER (Guy Gagnon), who finished fifth, and #8 GRITTY (Jacques Beaudoin) who finished eighth; after speaking with both drivers and reviewing the race video it was determined that #4 did go two wide with #2 STREET ART (Stephane Pouliot) then taking position three wide; before the ¾ mile pole #8 did bear out and slow hooking the wheel of #4 resulting in interference to #2, #4, #5 DOUBLE GUM (Robbie Robinson) and #6 THE MIDNIGHT TRAIN (Jason Gilchrist); no placing necessary as #8 finished behind all affected horses. Clear.
